

Payment Plans for Seminars in 2012

As many of you know, Concept: Synergy has for several years offered what's called a "Level Pay Plan" for seminars. The Level Pay Plan is designed for people who want to come to many seminars, but would rather make even monthly payments during the year rather than small amounts one month and much larger amounts at other times.

If you would like to use this service ...

- (1) Choose any combination of events scheduled in 2012 that you'd like to attend. Check them off on the schedule sheet, add up the total, and divide the total into twelve equal payments.
- (2) Read the level pay plan agreement and fill in the blanks. Make sure the figures on the agreement are accurate and that the figures for the events you've marked on the schedule match those on the agreement.
- (3) Finally, sign the agreement and send it to us along with your checks or the credit card number you'd like us to use. You can make your monthly payments either by placing checks on deposit with us dated for the next twelve months, or (if Concept: Synergy approves) by having us automatically charge a credit card number that you specify for this purpose.
- (4) Send us your Plan. We'll then email you to let you know your pay plan has been accepted, register you for the seminars you've chosen, and set up your Level Pay Plan.

Special Note: Please make sure your checks are dated 2012.

Please return your Level Pay Plan materials to us by January 1st, 2012. Thank you.

If you will be doing a Level Pay Plan with a credit card and your card will expire during the course of the plan, please make a note to call us with another credit card or an updated expiration date before your card expires.

LEVEL PAY PLAN AGREEMENT

AGREEMENT made this ____ day of _____, 20__, by and between Concept: Synergy of P. O. Box 37665, Raleigh, NC 27627 (hereinafter "CS") and _____ (hereinafter "Client") of _____ whose home phone is _____ and whose work phone is _____ and whose email address is _____ with reference to the following:

1. Concept: Synergy is the sponsor of all Lazaris events, and has scheduled a number of such events (the "Events") to occur during the next 12 months. The Events vary in length from one evening to three days, and in cost from \$50.00 to \$575.00.
2. Because of the way Events are scheduled, if one were to pay in full for each Event at the time of each Event, the total cost of attendance during any one month could vary from another month by as much as \$1,525.00.
3. Client has requested a payment plan whereby Client could select the Events he/she wishes to attend for the next 12 months, and then equally divide the total cost of all the selected Events so that Client would pay the same amount each month ("Level Pay Plan").
4. CS would like to create a Level Pay Plan for Client.

NOW THEREFORE, IN CONSIDERATION of the terms, conditions and covenants herein contained, as well as for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby expressly agree as follows:

5. Accompanying the Agreement is a sheet listing all the events (Exhibit A) and Client has checked the ones he/she would like to attend during the coming 12-month period (hereinafter "Selected Events"). Listed with each of the optional Selected Events is the full yearly advance admission price ("Total").

Client hereby acknowledges that the Total of all Selected Events given in Exhibit A and their respective 12 monthly payments (each being 1/12th of Total for the Selected Events) is as follows:

For all seminars, the Grand Total is \$ _____ with 12 monthly payments of \$ _____. (If you divide by 12 and the number does not come out evenly, adjust the last payment such that all payments add up to the total.)

6. CS hereby agrees that if Client deposits with CS twelve equal monthly payments as given for the choices made above by Client, either in the form of 12 checks dated for the 1st day of each month of 2012, or, if CS approves, a credit card number which Client agrees to have automatically charged for the amount listed above on the 1st day of each month of 2012, CS shall allow Client to attend all Selected Events as shown on Exhibit A and chosen by Client. If CS is unable to clear the payment by check or credit card which has been specified by Client, this Agreement will automatically be terminated and cancelled.

7. Client does not incur any obligation to attend all the Selected Events by entering into this Agreement. If Client does not wish to attend any Selected Event, he/she must notify CS in writing seven (7) days prior to said event. If Client shall not so notify CS, then Client shall be subject to all the standard cancellation terms and conditions.

8. Client by attending any Event pursuant to the terms of the Agreement hereby agrees to pay in full for each such Event attended. Therefore, upon termination of this Agreement, an accounting shall be made of the cumulative costs of all Events attended pursuant to this Agreement, and such amount shall be compared to the amount paid to CS by Client pursuant to this Agreement. If the amount paid exceeds the amount owed, Client will receive a full refund. If the amount owed exceeds the amount paid, Client shall immediately pay the difference to CS.

INTENSIVES AND INTERLUDES: OPTIONS FOR FEWER DAYS: Some people have problems getting time off to come to the 3-Day Intensives and Interludes. The 3-Day intensives are marked (1+2), which indicates an option to attend just on Saturday and Sunday. Interludes are available for one-, two-, or three-day participation.

EARLY REGISTRATION AND DISCOUNTED ROOM RATES FOR HOTELS: Discounted room rates are available at all hotels. However, in most cases rooms must be booked a month or more in advance to qualify for discounted rates. Lowered rates are also dependent upon whether our reservation block is sold out when you call. Please make your reservations as early as you can to ensure getting the best possible rate.
